

# The Mill ICC Dublin Limited

## Nerf Disclaimer

Thanks for choosing The Mill. Nerf, as any other sporting activity has various hazards associated with it and as a result we place safety above all else. Please read over the following disclaimer and pay attention to the points mentioned.

### **I Understand that:**

- Nerf is physically and mentally intense and may require exertion to play.
- The possibility of injury to myself and others exist.
- The playing area has vastly varying terrain as well as numerous obstacles (small and large) coming out of floors and walls.
- Areas of the arena may be wet and contain trip and slip hazards.
- **Eye Protection may not be removed at any time when in the arena. They may only be removed when in the reception area. Players will be banned if found removing Eye Protection.**
- Nerf Darts can cause bruising; by signing this declaration I am agreeing at all times to indemnify The Mill ICC Dublin Limited, its's employees, servants or agents against all liability, which it may incur, resulting from any claim by a third party, arising directly or indirectly from the players negligence as a participant whilst the player is present on site. Furthermore, by signing this document you are agreeing that you are participating entirely at your own risk.
- Obstacles and built cover such as tyres, pallets and sandbags have the potential to collapse and could cause physical harm to players nearby. Players are not to climb or attempt to collapse such cover or obstacles.
- Pyrotechnical devices are used in this arena, which may emit smoke and loud noises, these devices may cause injury if not used correctly, players should not approach any such device or attempt to tamper with them in any way. Doing so risks injury.
- No Markers/guns are allowed in the safe area (Reception).
- No physical contact is allowed between participants.
- Cars are parked in the car park entirely at owner's own risk.
- The site will not accept responsibility for valuables lost or damaged on the property, lockers are provided for safe keeping of valuables but must be used at the customers own risk.
- Any players disobeying site rules will initially be made to sit out a round for breaking any site rule and if the rule is purposefully broken again they will be asked to leave the property.

### **I Confirm and agree that:**

- I am physically fit and mentally able to take the strain and exertion involved in Nerf.
- I have no medical condition that would prevent me from playing. ( Please make the reception staff aware if you use an inhaler or any other medical aid).
- I am not under the influence of alcohol or controlled substances.
- I am fully aware of the risk to myself and others involved in Nerf and that I will never under any circumstances deliberately shoot anyone in the face, head or neck.
- I will wear goggles and not remove them whilst in the playing area (This includes all areas except the safe area (reception)).
- I will comply with the rules and use all equipment as instructed and not to injure or hurt others.
- I will obey all instructions from the game manager / site marshals.
- I will not shoot another player within 1m.
- I will not fire anything from the Nerf gun the darts provided by The Mill ICC Dublin Limited and will not attempt to tamper with or adjust the marker except in accordance with the safety briefing instructions.
- I will only use darts supplied by The Mill Dublin ICC Limited.
- All games I play at The Mill Dublin ICC Limited shall be at my own risk and I am fully aware that there are hazards on site, including (but not exhaustive), wooden props, structural pillars, sharp objects, steel pillars/beams, sandbags, tyres, steps, below head height door openings and passages, windows, walls, barrels, slippery/uneven surfaces and risk of collision between players.

- At all times I am indemnifying The Mill Dublin ICC Limited, it's employees, servants, or agents in respect of death or personal injury or other accident, illness or damage to persons or property however this may arise or be caused.

I have read and fully understood agreement. I am aware that by signing this agreement I acknowledge and accept the inherent risk of injury Nerf entails.

I confirm that I have attended and understood the safety briefing. I have asked anything I am unsure of or did not understand and was answered with an explanation by staff before signing this document.

I state that I am over 16 years or age and legally competent to sign this certificate. If under 16 years of age this form must be countersigned by a parent or group organiser who must be 18+ years of age. By signing this form, the parent or guardian accepts that they agree with all the above statements and confirms that the participant is 6 years or older on the date of play.
